THE FINANCIAL STATE OF IDAHO

Why did Idaho's reported pension debt increase by \$193.6 million this year?

Because of a new accounting rule, Idaho now has to report its pension debt on its balance sheet. As a result, the state's reported pension debt grew from \$14.3 million in 2014 to \$207.9 million in 2015. However, the state is still hiding \$148.3 million of pension debt from taxpayers.

For years, Truth in Accounting has called for this financial reporting change, and we welcome the shift towards more transparent accounting.

The state's assets exceed its bills

Idaho has \$17.1 billion in assets, but most of these assets are not available to pay state bills.

The \$7.7 billion of capital assets, such as roads, buildings, and land should not be sold to pay bills. The use of \$4.8 billion of the assets is restricted by law or contract.

That leaves \$4.6 billion of the state's assets available to pay \$3.5 billion of bills as they come due.

Key findings

- Idaho has \$4.6 billion available to pay \$3.5 billion worth of bills. Therefore, the state has a \$1.1 billion surplus.
- Idaho has a taxpayer surplus of \$2,400, which is each taxpayer's share of the state's excess funds.
- Despite reporting most of its pension debt, the state still continues to hide most of its retiree health care debt. The state's total hidden debt is \$223.3 million.

The bills Idaho has accumulated

Bonds	\$2,496,268,000

The state has accumulated bonds of \$2.5 billion and other liabilities of \$1.8 billion. The calculation of assets available to pay bills does not include capital assets, so \$1.2 billion of related debt is removed from the calculation of state bills.

Unfunded employees' retirement benefits represent 13% of state bills. These unfunded liabilities have accumulated because state employees have been promised \$356.2 million of pension benefits and \$119.3 million of retiree health care benefits. Unlike most states, Idaho has the assets needed to pay these liabilities.

Idaho's elected officials seem to promise only the amount of benefits they can afford to pay.

Data is derived from the state of Idaho's June 30, 2015 audited Comprehensive Annual Financial Report and retirement plans' actuarial reports.

Number of taxpayers is based on an estimation of the state's population with a federal tax liability.
