The Commonwealth's Bills Exceed Its Assets

Puerto Rico has \$68.9 billion in assets, but most of these assets are not available to pay \$114.8 billion of bills.

The \$38.3 billion of capital assets, such as roads, buildings, and land should not be sold to pay bills. The use of \$3.3 billion of the assets is restricted by law or contract.

That leaves \$27.3 billion of the commonwealth's assets available to pay \$114.8 billion of bills as they come due.

The -\$87.5 billion shortfall represents compensation and other costs incurred in prior years that should have been paid in those prior years. Instead these costs have been shifted to future taxpayers.

The Bills Puerto Rico Has Accumulated

Despite the balanced budget requirement, the commonwealth has accumulated bonds of \$58.7 billion and other liabilities of \$37.5 billion. The calculation of assets available to pay bills does not include capital assets, so \$27.1 billion of related debt is removed from the calculation of commonwealth bills.

Unfunded employees' retirement benefits represent 40% of commonwealth bills. These unfunded liabilities have accumulated because commonwealth employees have been promised \$43.6 billion of pension benefits and \$2.1 billion of retirees' health care benefits, but the commonwealth has not adequately funded them.

Unless these pension and retirees' health care benefits are renegotiated, future taxpayers will be burdened with paying for these benefits without receiving any corresponding government services or benefits.

Not All Retirement Liabilities Are Clearly Disclosed



A detailed study of Puerto Rico's actuaries' schedules found retirement benefits totaling \$45.7 billion have been promised, but not funded. A review of the commonwealth's balance sheet determined only \$14.9 billion of these liabilities are reported. This means the commonwealth does not report \$30.8 billion of retirement liabilities on its balance sheet.

Data is derived from the Commonwealth of Puerto Rico's June 30, 2014 audited Comprehensive Annual Financial Report and retirement plans' actuarial reports.

Number of taxpayers is based on an estimation of the commonwealth's population with a federal tax liability.
