THE FINANCIAL STATE OF ARLINGTON

Why did Arlington's reported pension debt increase by \$87.1 million this year?

Because of a new accounting rule, Arlington now has to report its pension debt on its balance sheet. As a result, the city's reported pension debt grew from \$17.5 million in 2014 to \$104.6 million in 2015.

For years, Truth in Accounting has called for this financial reporting change, and we welcome the shift towards more transparent accounting.

The city's assets exceed its bills

Assets	\$2,918,994,000
Minus: Capital assets	-\$2,299,943,000

Arlington has \$2.9 billion in assets, but most of these assets are not available to pay city bills.

The \$2.3 billion of capital assets, such as roads, buildings, and land should not be sold to pay bills. The use of \$161.8 million of the assets is restricted by law or contract.

That leaves \$457.2 million of the city's assets available to pay \$441.2 million of bills as they come due.

Key findings

- Arlington has \$457.2 million available to pay \$441.2 million worth of bills. Therefore, the city has a \$16 million surplus.
- Arlington has a taxpayer surplus of \$100, which is each taxpayer's share of the city's excess funds.
- Despite reporting most of its pension debt, the city still continues to hide most of its retiree health care debt. The city's total hidden debt is \$85.9 million.

The bills Arlington has accumulated

Bonds	\$680,646,000
Other liabilities	\$104,723,000
Minus: Debt related to capital assets	-\$570,388,000
Unfunded pension benefits	\$104,234,000
Unfunded retiree health care benefits	\$122,020,000
Bills	\$441,235,000

The city has accumulated bonds of \$680.6 million and other liabilities of \$104.7 million. The calculation of assets available to pay bills does not include capital assets, so \$570.4 million of related debt is removed from the calculation of city bills.

Unfunded employees' retirement benefits represent 51% of city bills. These unfunded liabilities have accumulated because city employees have been promised \$104.2 million of pension benefits and \$122 million of retiree health care benefits. Unlike most states, Arlington has the assets needed to pay these liabilities.

Arlington's elected officials seem to promise only the amount of benefits they can afford to pay.

Data is derived from the city of Arlington's September 30, 2015 audited Comprehensive Annual Financial Report and retirement plans' actuarial reports.

Number of taxpayers is based on an estimation of the city's population with a federal tax liability.
