Submit a Claim Against Illinois Governor Pritzker for Violating the SEC's Cease and Desist Order over Pension Solvency.

01. Visit www.sec.gov/tcr

Click the green "Submit a Tip or Complaint" button on the right side of the page.

Select “Material misstatement or omission in a company's public filings or financial statements, or a failure to file”

Then select “False/misleading press release” under the special category.
