THE FINANCIAL STATE OF PENNSYLVANIA

Why did Pennsylvania's reported pension debt increase by \$14 billion this year?

Because of a new accounting rule, Pennsylvania now has to report its pension debt on its balance sheet. As a result, the commonwealth's reported pension debt grew from \$0 in 2014 to \$14 billion in 2015. However, the commonwealth is still hiding \$21.7 billion of pension debt from taxpayers.

For years, Truth in Accounting has called for this financial reporting change, and we welcome the shift towards more transparent accounting.

The commonwealth's bills exceed its assets

Pennsylvania has \$93.3 billion in assets, but most of these assets are not available to pay commonwealth bills.

The \$44.4 billion of capital assets, such as roads, buildings, and land should not be sold to pay bills. The use of \$8.2 billion of the assets is restricted by law or contract.

That leaves \$40.7 billion of the commonwealth's assets available to pay \$106.5 billion of bills as they come due.

The -\$65.8 billion shortfall represents compensation and other costs incurred in prior years that should have been paid in those years. Instead these costs have been shifted to future taxpayers.

Key findings

- Pennsylvania has only \$40.7 billion available to pay \$106.5 billion worth of bills. Therefore, the commonwealth has a -\$65.8 billion financial hole.
- Pennsylvania has a taxpayer burden of -\$15,500, which is each taxpayer's share of the commonwealth's unfunded debt.
- Despite reporting more of its pension debt, the commonwealth still continues to hide most of its retiree health care debt. The commonwealth's total hidden debt is \$40.2 billion.

The bills Pennsylvania has accumulated

Despite the balanced budget requirement, the commonwealth has accumulated bonded debt of \$33.2 billion and other liabilities of \$28 billion. The calculation of assets available to pay bills does not include capital assets, so \$13 billion of related debt is removed from the calculation of commonwealth bills.

Unfunded employees' retirement benefits represent 55% of commonwealth bills. These unfunded liabilities have accumulated because commonwealth employees have been promised \$35.7 billion of pension benefits and \$22.6 billion of retiree health care benefits, but the commonwealth has not adequately funded them.

Unless these pension and retiree health care benefits are renegotiated, future taxpayers will be burdened with paying for these benefits without receiving any corresponding government services or benefits.

Data is derived from the commonwealth of Pennsylvania's June 30, 2015 audited Comprehensive Annual Financial Report and retirement plans' actuarial reports.

Number of taxpayers is based on an estimation of the commonwealth's population with a federal tax liability.
